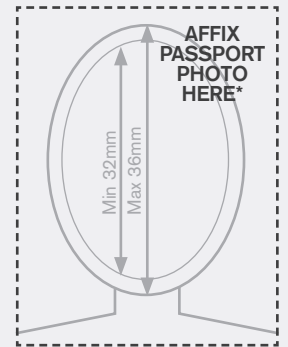

## APPLICATION PROCESS

Once your application form has been received it will be presented before the Board of Directors of the Victoria Racing Club for approval. Upon approval of your application, we will provide you with a confirmation and process your payment according to your chosen option outlined below.

**Payment option 1:** allows you to pay the joining fee of \$726 and the reduced Young Restricted Membership fee of \$159 upfront in year one.

**Payment option 2:** allows you to pay the joining fee of \$726 in two instalments. For the first year of membership, you will pay a combined fee of \$522 which includes the reduced Young Restricted Membership fee of \$159 and the first instalment of the joining fee. The second instalment of the joining fee will be due on the earlier of when you: (i) renew for your second year of membership; or (ii) cease to be a member of Victoria Racing Club.

**Payment option 3:** allows you to pay the joining fee of \$726 in three instalments. For the first year of membership, you will pay a combined fee of \$401 which includes the reduced Young Restricted Membership fee of \$159 and the first instalment of the joining fee. The second instalment of the joining fee will be due when you: (i) renew for your second year of membership and the third instalment of the joining fee will be due in your third year of membership, or (ii) cease to be a member of the Victoria Racing Club.
